

ENVIRONMENTAL FUEL SOURCE INFORMATION

THIS DISCLOSURE IS REQUIRED BY THE DISTRICT OF COLUMBIA PUBLIC SERVICE COMMISSION

The following environmental information is for Pepco customers who have not chosen an alternative electricity supplier.

Power plants can generate electricity from a number of different fuel sources, resulting in different emissions. Pepco will report fuel sources and emissions data to customers twice annually, allowing customers to compare data among the companies providing electricity service in the District of Columbia.

The electricity provided to Pepco's customers is supplied by the PJM Interconnection (PJM). PJM is the federally regulated regional transmission system operator that coordinates the movement of wholesale electricity in all or parts of Delaware, Illinois, Indiana, Kentucky, Maryland, Michigan, New Jersey, North Carolina, Ohio, Pennsylvania, Tennessee, Virginia, West Virginia and the District of Columbia.

The standardized environmental data provided are for January 1, 2019 – June 30, 2019.

Although the renewable energy resource subtotal in the District is 6.6%, this supply must comply on an annual basis with the District of Columbia Renewable Energy Portfolio Standard (RPS) requirements of 18% for the 2019 year. Pepco requires the Standard Offer Service suppliers to purchase renewable energy and Renewable Energy Credits from approved resources in the District of Columbia and the PJM area.

AIR EMISSIONS

The amount of air pollution associated with the generation of electricity for the PJM region, which includes Pepco, is shown below.

CO₂ is a "greenhouse gas," which may contribute to global climate change. SO₂ and NO_x released into the atmosphere react to form acid rain. NO_x also reacts to form ground level ozone, an unhealthy component of "smog."
